Day of trial entering will be possible if runs are available.

Programs/Divisions offered:

Championship Program ~ Standard, Veterans and Junior Handler Divisions

ACE Program ~ Standard and Senior Dog Divisions

Saturday, June 1st

2 rounds of Jumpers (EEOONN), 2 rounds of Regular (EEOONN), 2 rounds of Gamblers (EONEON).

Sunday, June 2nd

2 rounds of Gamblers (EONEON), 2 rounds of Regular (EEOONN), 2 rounds of Jumpers (EEOONN).

Entries limited to 350 runs per day

Trials will be held under the current rules and regulations of ASCA®

No entry shall be accepted from a dog or handler disqualified from the ASCA® agility program, a dog or handler disqualified from all ASCA® programs, or a person not in good standing with ASCA®

An ASCA registration number is not required for entry, however, if you would like to have qualifying scores recorded and receive titling certificates, an ASCA registration or tracking number is required. ASCA Tracking Number and Service Membership Application can be found at:

Measuring and day of trial entries (if still available): 07:30 – 08.00 AM)

Briefing and walking the course: 08.00 – 08.30 AM First run at: 08.30 AM

~Entry fees~

Pre-entries 8 € per run

Late entries / Late payment / entries on day of trial 10 € per run

In case of illness of dog or handler the entry fees will be reimbursed if a certificate by the vet or doctor is given to the trial secretary.

~Measuring ~

Dogs not jumping in the 20" +/24" (16" + veteran and juniors) will require proof of measurement (ASCA/AKC/NADAC height card) or be measured at the trial.

~Move ups~

Move-ups will be accepted until 1 hour after the last class on the day before move-up.

~Ribbons & Awards~

Flats for 1st - 4th and Qualifying runs. Jump heights 20, 20+, and 24" will be combined for placements in the Standard division, and 16 and 16+ will be combined for placements in the Veteran division, HIT (High in Trial Overall Standard division, Veteran Dog High in Trial, Junior High in Trial) and some special awards will be given at the club's discretion.

Rule for being calculated for HIT Award (Agility rule book section 2.6.2 c):

Each faultless qualifying run in Regular Agility, Gamblers, or Jumpers shall be given the following HITQ-point value: runs in an Elite class shall be given 7 HITQ-points; runs in an Open class shall be given 6 HITQ-points; runs in a Novice class shall be given 5 HITQ-points. Each faulted (.01 to 5 faults) qualifying run in Regular Agility shall be given one-half the value of the equivalent level HITQ-points (runs in an Elite class shall be given 3.5 HITQ-points; runs in an Open class shall be given 3 HITQ-points; runs in a Novice class shall be given 2.5 HITQ-points).

~Obstacles~

The following obstacles may be used in this trial:

Weave poles-22" spacing, A-frame, dogwalk, teeter-totter, open tunnel, winged jumps, non-winged jumps. Contacts are non-slatted with rubber surface.

Bitches in heat - NO BITCHES IN HEAT MAY COMPETE!!!

(see ASCA rules, chapter 1 section 1.3)

Entry fees will be reimbursed if there is a written statement from the owner that the bitch is in heat.

Should it be necessary to cancel the trial due to circumstances beyond the control of ASVA e.V., the club reserves the right to withhold part of the entry fee to cover costs already incurred.

GENERAL ENTRY INFORMATION

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations, and agree to abide by all rules in effect at the time of this trial. No entry shall be accepted from a dog or handler disqualified from ALL ASCA programs. Anyone who is not currently in good standing with ASCA will not be allowed to enter the trial.

ASVA will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee be asked to leave the show grounds. In such case, no refund of fees paid will be made.

Dogs must be ready for judging. Neither the club nor the chairman will be responsible or obligated to furnish any services for notifying exhibitors or their agents of class judging. Entry fees will not be refunded in the event a dog is absent, disqualified, excused, or barred from competition by action of the show committee.

The show giving club, the Show Chairman, their agents, officers, and/or committee shall assume no responsibility for injury to children. Judge may be substituted. Please make sure you specify your payment(s) as much as possible, name handler (if different than the person making the payment), name of dog. All dogs must be leashed or crated at all times, except when competing. No electrical and/or mechanical training devices will be permitted on the show grounds. No bitches in heat in or near the agility ring are allowed.

All dogs must have current vaccinations against rabies. Please have proof available when picking up your entry number or entering a dog on day of trial. Puppies under 16 weeks need to have had their first shots. Dogs without correct vaccination papers cannot start.

Entries for the Agility trial do not require a registration number to compete, only for titles. For dogs that do not have an ASCA registration, but do want to earn titles, a QTracking number is needed. AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

- 1.1 As used here, "ASCA" means the Australian Shepherd Club of America, Inc., affiliate clubs and each of their members, officers, directors, employees, show committees and agents.
- 1.2 Exhibitor/owner agrees to abide by the rules and regulations of ASCA and any other rules and regulations appearing in the premium for this event.
- 1.3 Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack thereof, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
- 1.5 Exhibitor/owner release ASCA (including ASCA officers, directors, employees, and members), ASVA e.V (including its officers, agents, and employees), and Freundliche Hundefreunde Viersen e.V (including its officers, agents and employees), and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Exhibitor/owner hereby assumes sole responsibility for and agrees to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
