Rally: 2 starts on one day 40,- EUR / 2 starts on both days 70,- EUR (Masters/Excellent)

Third-Party Insurance:

All dogs entering the trial grounds must be insured against third-party risk.

Vaccinations:

We will NOT check passports from the dogs on the ground. Please send a copy of the page “description

of animal” (with your dog’s name) and the page of your dog’s current rabies shot when sending the entry!!

Please follow these rules due to the COVID-19 Virus:

- please do not attend the event if you have any flu symptoms
- we need to register each person that is at the ground when entering. You will get an armband that you need to wear to see that you’re registered.
- please disinfect your hands
- please keep the minimum distance of 1,5m
- please wear a mask when the distance of 1,5 m to the next person is not given and
- **PLEASE BRING the attached document with you!**

Refund of Pre-entries & Class Changes

Pre-entries will be refunded only upon written request received prior to close of pre-entries. No class changes will be made once entries have closed.

Refunds: We will refund 100% if you have to cancel your starts later because of the condition of handler and/or dog (illness, injury, death), please cancel in writing and enclose a vet/doctor statement. 100% are also refunded if you cancel because of a judge’s change.

All current ASCA rules and regulations apply. No entry shall be accepted from a dog or handler disqualified from the ASCA Rally/Obedience program; a dog or handler disqualified from All ASCA programs; or a person not in good standing with ASCA. All dogs 6 months of age and over must have individual registrations to compete in all ASCA sanctioned events. Jr. Handlers must enter all required information. All entries must be on the new official ASCA entry forms with the agreement/disclaimer & signature on back. Incorrect and or missing information will invalidate entries.

Open: Open B CDX, Open B ODX, Open A CDX, Open A ODX (the order of exercises for Open B CDX/ODX will be posted in time on the grounds)

Novice: Novice B, Novice A

Novice Beginner: Novice BeginnerB, Novice Beginner A

The long sit and down in Open and Novice might be combined for the B and A starters each according to the entries in each class. The order of group and single exercises in the Open and Novice classes will be posted on the grounds in time.

Novice Beginner: Novice Beginner B, Novice Beginner A

The award ceremony for each class will be held after the last starter in each class. The HIT (High in Trial) and if applicable HSJH (Highest Scored Junior Handler) and/or HCS (Highest Combined Score) will be awarded and the end of the trial.

Any healthy and trained dogs (Aussies, other breeds and also crossbreeds) 6 months or older are allowed to compete with an appropriate ASCA registration (individual, LEP or tracking no.). **Bitches in heat are not allowed to compete!**

Advanced: Advanced C, Advanced B, Advanced A
Novice: Novice C, Novice B, Novice A

The award ceremony for each class will be held after the last starter in each class. The HIT (High in Trial) and if applicable HSJH (Highest Scored Junior Handler) will be awarded and the end of the trial. Any healthy and trained dogs (Aussies, other breeds and also crossbreeds) 6 months or older are allowed to compete with an appropriate ASCA registration (individual, LEP or tracking). **Bitches in heat are not allowed to compete!**
